## MIXING INSTRUCTIONS

- 1. Fill spray tank to three guarters of required water volume.
- 2. Add pesticide to spray tank whilst mixing continuously.
- 3. Add measured amount of PROMAX to the spray mix.
- 4. Top up with water to required volume whilst mixing.
