#### MIXING INSTRUCTIONS

Before adding to a spray tank or knapsack premix PRODYE BLUE with water at a ratio of 1:10. Once premixed solution is added to a spray tank or knapsack add more water to half fill the tank. While agitating the solution add other ingredients then add more water to fill the tank. To avoid discolouration from product residue all spraying equipment should be washed out thoroughly after each use.
